
Mayor called a brief recess at 7:14pm

Motion was made by Council Member Koepsel to approve Ordinance 421-19 – **AN ORDINANCE OF THE CITY OF ROMAN FOREST, MONTGOMERY COUNTY, TEXAS, SUPPLEMENTING CITY ORDINANCE NO. 308, DATED FEBRUARY 16, 1998, BY PROHIBITING COMMERCIAL MOTOR VEHICLE TRUCK TRAFFIC OVER 52,000 POUNDS ON ALL CITY STREETS IN THE CITY; REQUIRING PERMITS OF UP TO \$500 FOR EACH COMMERCIAL MOTOR VEHICLE WEIGHING BETWEEN 15,000 POUNDS AND 52,000 POUNDS WHICH DRIVES THROUGH THE CITY TO DESTINATIONS BEYOND THE CITY; AUTHORIZING THE CITY ADMINISTRATOR TO POST APPROPRIATE WEIGHT LIMIT SIGNS; PROVIDING A SEVERABILITY CLAUSE AND REPEALING CLAUSE; PROVIDING A TEXAS OPEN MEETING ACT CLAUSE; AND DECLARING AN IMMEDIATE EFFECTIVE DATE.**

Action, if any, will be taken in open session.

This agenda has been reviewed and approved by the City's legal counsel and the presence of any subject in any Executive Session portion of the agenda constitutes a written interpretation of Texas Government Code Chapter 551 by legal counsel for the governmental body and constitutes an opinion by the attorney that the items discussed therein may be legally discussed in the closed portion of the meeting considering available opinions of the Texas Attorney General known to the attorney. This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144© and the meeting is conducted by all participants in reliance on this opinion.

The members of the boards, commissions and/or committees may be permitted to participate in discussions on the same items listed on the agenda, which occur at the meeting, but no action will be taken by such in attendance unless such item and action is specifically provided for on an agenda for that body, board, commission or committee subject to the Texas Open Meetings Act.
